

BOROUGH OF HIGHLANDS COUNTY OF MONMOUTH

ORDINANCE 0-20-26

AN ORDINANCE AMENDING SECTION 7-3.5 OF BOROUGH CODE TO ADDRESS PUBLIC PARKING REQUIREMENTS

WHEREAS, pursuant to N.J.S.A. 39:4-197, the Borough has the authority to pass an Ordinance, without the approval of the Commissioner of the Department of Transportation, and consistent with the current standards prescribed by the Manual on Uniform Traffic Control Devices for Streets and Highways, relating to the regulation of parking of vehicles upon land owned by the municipality; and

WHEREAS, the governing body of the Borough of Highlands wishes to amend its recently-revised public parking requirements to correct the block and lot designation for Police Department Parking and to address parking at 42 Shore Drive and to clarify the exemptions to this subsection.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Highlands as follows:

SECTION I.

Borough Code Section 7-3.5 "Regulation of Municipal Parking" shall be amended as follows: (All additions are shown in **bold italics with underlines.** The deletions are shown as **strikeovers in bold italics**.)

a. Public parking shall be permitted within any designated parking stalls in the following municipal parking lots between the hours of 5am and 11pm. No overnight public parking between the hours of 11pm and 5am shall be permitted.

Parking shall be prohibited in the following municipal lots on Tuesdays between 6am and 9am for maintenance:

- b. All vehicles shall park within the white lines designated for each separate parking space in any municipal parking lot or on any street, and any person parking a vehicle over any dividing line, or parking any vehicle beyond the end of such parking lines, shall be guilty of a violation of this subsection.
 - c. Public parking is prohibited at the times and locations specified:

- d. The governing body is empowered to reserve spaces by resolution for specific borough employees, officials or departments, or residents as specified by posted signs or markings on the pavement, and the prohibitions and restrictions set forth in this chapter shall not apply to those borough employees, officials, departments, or residents validly parked pursuant to such resolutions.
 - e. The following are exempt from the parking restrictions set forth in this subsection:

Municipal vehicles shall be exempt from parking and time restrictions.

Fire Department members are exempt when parking at the Fire Department.

Police Department members are exempt from parking restrictions at 27 Shore Drive.

Those portions of municipal lots that are leased <u>or otherwise subject to limitations set</u> <u>forth in an agreement</u> and not open to the public shall be exempt from the above restrictions and subject to any restrictions set forth in the <u>lease</u> agreement.

Those portions of municipal lots on which parking is otherwise required or allowed by law or by temporary order of the Chief of Police shall be exempt from the restrictions set forth in this subsection.

SECTION II. SEVERABILITY. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance, which shall otherwise remain in full force and effect.

SECTION III. REPEALER. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV. EFFECTIVE DATE. This ordinance shall take effect immediately upon its passage and publication in accordance with law.
