Ordinances: Public Hearing & Possible Adoption

O-18-02 – Amend Chapter 17, Establishment of Business District

Mayor O'Neil opened the meeting for a public hearing on Ordinance 18-02.

Carol Bucco, Shore Drive, inquired if the business owners had been surveyed yet. Ms. Gonzales stated that the Borough has not sent them out yet.

Councilmember D'Arrigo informed the public that her task was to reach out to the unhappy business owners, not to send out a survey to all businesses.

Steve Solop, Bay Avenue, commented that he didn't see a point to passing the ordinance without sending out the surveys first. He noted that the Borough should look at how to fix the HBP before they renew the ordinance. Mr. Solop noted that he did not get a response to his inquiry on the Highlands Business Partnership's (HBP) budget. Ms. Solop said that the focus of the HBP should growing the center of the Borough. He discussed an event that Katz and he had put on the past summer noting its success.

Councilmember D'Arrigo noted that the results had not been released as the Council would be repolling all the businesses.

Carla Cefalo, Gravelly Point Road, informed the Council that all the information that Ms. Solop is seeking was provided to the business owners along with being available on the HBP's website. She added that it is not the Business Improvement District's (BID) responsibility to bring customers to an individual business but rather market the Borough as a destination.

Ms. Cafalo asked where all the disgruntled businesses owners were because the HBP was not aware of them. She added that the HBP has worked with unhappy business owners in the past and corrected the

situations. She explained that they will not always make everyone happy but has to work for the greater good.

Mayor O'Neil suggested that the HBP members work together to remedy this situation. Councilmember D'Arrigo stated that these issues have been ongoing for years and things need to change.

Carla Cafalo, Gravelly Point Road, invited Councilmember D'Arrigo to attend the next HBP meeting.

Steve Solop, Bay Avenue, commented that the HBP holds their events only in certain locations and inquired where the monies designated for the beautification was spent. Mr. Solop and Ms. Cafelo had an exchange of words. Mayor O'Neil pointed out that these concerns should be addressed with the HBP. Mr. Solop stated that he already tried.

Chris Francy, Fifth Avenue, noted that the internal workings of the HBP should not be part of this conversation and suggested that Mr. Solop work with the Council liaison.

Kim Skorka, Shore Drive, stated that according to the ordinance the HBP is responsible for 15 actions and is only working on one. She asked what the HBP is doing for the other 14 actions. She expressed her belief that the HBP is not doing their job and should pay for their events. Ms. Skorka commented that the HBP events should be held in parks, not bars. She also questioned how the HBP measures their success and who paid for some of the improvements on Bay Avenue. Mr. Leuber explained the funding for the improvements.

Councilmember D'Arrigo expressed some of her concerns with the running of the HBP's events and commented that the Recreation Department should be hosting some of these events.

Kim Skorka, Shore Drive, stated that the Council is approving the HBP to operate in the Borough. She reviewed the many issues she has with the HBP and asked the Council to reevaluate their stance.

Mayor O'Neil responded to Ms. Skorka's comments and encouraged people to become involved in the HBP. He stated that he will look into the cost of the events on the Borough.

Steve Solop, Bay Avenue, commented that he doesn't believe the current HBP leadership is capable to taking care of some of the Borough's businesses' needs.

Councilmember Broullon explained that the Council can't do anything concerning the HBP leadership as the members elect their leadership. Ms. Gonzales suggested that Mr. Solop attend the next meeting with her and that they will see what they can do to work together.

Michael Cannon, Central Avenue, stated that he thought some changes might be needed to the ordinance and that should be the focus of this discussion. He asked how the ordinance can be amended to have the leadership better serve the businesses.

Councilmember Broullon explained the Council's role with the HBP noting that State statue governs it.

Councilmember Ryan commented that she was a member of the HBP and noted their membership diversity and the need for the HBP in the Borough. She commented that the HBP normally has a low member turnout at the meetings and invited others to attend.

Councilmember D'Arrigo explained that some businesses are hurt by the HBP's events and noted that the businesses can't opt of the BID. Councilmember Broullon explained that businesses can opt out and the process to do so.

Steve Solop, Bay Avenue, stated that unhappy business owners are fearful of retaliation by the HBP.

Carla Cefalo, Gravelly Point Road, addressed some of the comments made throughout the meeting. Councilmember D'Arrigo informed Ms. Cafalo that people are afraid of her. Ms. Cefalo and Councilmember D'Arrigo discussed the topic.

Kim Skorka, Shore Drive, commented on the arduous process to leave the BID.

Mayor O'Neil closed the meeting to the public.

Councilmember Broullon shared a story of how HBP events have brought new people to the Borough.

Councilmember Ryan motioned to adopt Ordinance 18-02 which was seconded by Mayor O'Neil. Mayor O'Neil commented on why he was voting to adopt the ordinance.

Other Business

Army Corp of Engineers

Councilmember Ryan explained that Congressman Pallone had reached out to herself and Councilmember Braswell to discuss the sea wall project. She said that they had sat down for a meeting with Congressman Pallone and the Army Corp of Engineers and spoke to them about the Borough's issues with flooding. She reviewed the discussions of the meeting and noted that they asked the Borough to reconsider building the wall, having a feasibility study preformed without commitment, maintenance of the wall, and funding options if the Borough decided to move forward.

Councilmember Braswell expressed his concerns stemming from the meeting including the impact on the sewer, tides, and ground water.

Councilmember D'Arrigo inquired if the Army Corp of Engineers would put all of this in writing. Councilmember Ryan confirmed that the Army Corp of Engineers said they would put things in writing , as well as, meet with the rest of Council. Councilmember Broullon noted that she would like to see a scale model of the proposed wall. The Council discussed their concerns with the sea wall project and the impact on the residents. The Council decided to ask the Army Corp of Engineers to put everything in writing prior to making any decisions.

Engineer's Report

Mr. Leubner provided an update on bringing electricity to Veterans' Park, the duckbill valves, and the road project on the hill. He also commented on expected grants.

Police Chief Update

Chief Burton informed the Council that there was a new LED stop sign on the corner of Shore Drive & Waterwitch Avenue. He commented on the positive press that Officer Kevin O'Donnell had received for doing a good deed. Chief Burton also noted that he is working on the county on signage and disabled parking.

Administrator's Report

Ms. Gonzales informed the public that there is a new phone extension just for storm issues. She noted the old trailer is now removed and the 2017 Valley Street project is ready to go out for bid.

Mayor O'Neil commented that the Borough would be looking into amending the snow ordinance in relations to parking.

Public Comment

Carol Bucco, Shore Drive, stated that she had attended all the previous public meetings with the Army Corp of Engineers and asked the Council not to reconsider the sea wall. She commented that the cost to maintain the wall was excessive and if everyone lifted their homes it would not be needed.

Ms. Bucco inquired why the Borough was hosting town hall meetings on the new Borough Hall is the property is already under contact.

Ms. Bucco expressed opposition to there being trainings and meetings for drug addicts and their families at Borough facilities. Ms. Gonzales explained that the training was being funded by a grant and ran by the Community Alliance.

Ms. Bucco commented on the FEMA letter designating the AE Zone and thanked Councilmember D'Arrigo for her work. Councilmember Broullon discussed the letter with Ms. Bucco.

Mike Cannon, Central Avenue, noted he was new to the Borough and expressed his concerns about moving to the Borough stemmed from flooding and having to move cars. He commented that he doesn't believe the Borough can just walk away from the sea wall project noting that many of these projects have been successful.

Chris Francy, Fifth Avenue, asked if the bid specs for Valley were ready and if they were not could he be notified when they are as he would like to review them.

Annmarie Tierney, Shrewsbury Avenue, complimented the Department of Public Works for the excellent job snow plowing.

Councilmember Braswell also noted that he received compliments on the snow plowing.

Mayor O'Neil closed the meeting to the public.
