Engineer's Report

Mr. Herrman introduced himself to the community and noted his expectations and plans for the Highlands. He listed projects he would be working on and Mayor O'Neil explained the importance of these projects.

Public Comment

Mayor O'Neil opened the meeting to the public.

Steve Solop, Bay Avenue, informed the Council that he had been sharing his concerns about the HBP since August and was told that Councilmember D'Arrigo would be looking into the HBP. He asked if Councilmember D'Arrigo had any results or findings that could be reported. Councilmember D'Arrigo explained her concerns with the HBP and summarized the results of the survey. Mr. Solop expressed his frustration and asked the Council to read the results of the survey into the record at a Council meeting.

Mr. Chabarek explained to Mr. Solop that he could request the results through the Open Public Records Act (OPRA).

Ms. Solop informed the Council that he thought a committee was needed to be formed to review the results and handle this situation. Mayor O'Neil said that these concerns with the HBP should be addressed directly with the HBP. Mr. Solop commented that the HBP meetings are useless and listed the problems he has with the HBP. Councilmember D'Arrigo discussed the survey results and explained her view that the responsibilities of the HBP's events should be divided between the HBP and a Recreation Department. Councilmember D'Arrigo noted that she feels the Council cannot look at this issue impartially. Council discussed the accusation and Mr. Chabarek explained the ethics law.

Carol Bucco, Shore Drive, questioned how the survey would be anonymous. Councilmember Broullon explained online surveys and how they work.

Ms. Bucco commented on Resolution 18-53 from the previous meeting concerning expanding the Henry Hudson Trail. She stated that the County had provided the Borough with money to connect the trail and the bridge. Councilmember Ryan explained the previous grant money was for the intermunicipal bike path which Ms. Bucco debated with her.

Ms. Bucco stated that she was disturbed by the Two River Times and how they had been reporting things in the Borough which was discussed by Council. Ms. Bucco also noted that she believes the Council needs to stop revisiting old issues like the Army Corp of Engineers' seawall project which she expressed her opposition to.

Nancy Burton, In the Garden/Atlantic Street, pointed out that at the Council meetings most of the business owners in attendance are pleased with the HBP. She announced that she OPRA'ed the surveys and had reviewed them noting they are not all negative. Ms. Burton expressed her excitement for the new survey to be sent out.

Mayor O'Neil stated that many of the complaints the Council is hearing on the HBP should be directed at and handled by the HBP. He added that he sees both sides of the issue.

Kim Skorka, explained that she was offended by a quote in the Two River Times' article which addressed making the Borough a safer place for bicyclists. She explained that the Borough needs to work on pedestrian safety. Mayor O'Neil stated that the Council would take it into advisement.

Carol Bucco, Shore Drive, stated that she had spoken to Carla Cefalo from HBP and encouraged her to provide a more detailed budget.

Mayor O'Neil closed the meeting to the public.
