Other Business

Paradise Lane

Mr. Chabarek explained the history of how the name of the street was changed to Paradise Lane by Ordinance 18-11 and the process that is required to change a street name. Ms. Gonzales stated that she had been in contact with Pulte during this process. Councilmember Broullon invited the interested parties to speak.

<u>Sean Morning</u>, Pulte Group, stated that is an Pulte Trustee for the Harborside at the Hudson. He asked that the name could be changed to "Harborside Point" and added that they agreed to pay all expenses to change the street name again. Mr. Chabarek noted some of the costs associated with amending the ordinance. Councilmember Broullon stated that they would look into the coats and be in touch.

Recycling Coach App

Councilmember Broullon noted that the NJ DEP now has a phone application for recycling to help remind residents of what days to put out their trash and recycling. She explained the app and how it would benefit the Borough's residents.

Engineers Report

Mr. Herrman announced that the 2017 Road Improvement Project was complete. He updated the Council on the Shore Drive pump replacement, Veterans' Park electric, the sewer connection for the Police Department, and the Valley Street storm water designs. Mr. Herrman advised residents to contact their insurance companies now that the new FEMA maps were adopted.

Councilmember D'Arrigo noted that there would be more movie nights this summer and the concert nights that Recreation is sponsoring.

Mr. Chabarek informed the public that there was an inaccurate flyer being spread around the Borough concerning the upcoming Land Use Board (LUB) meeting. He noted the correct time, date, and location of the next meeting. Councilmember Braswell noted that the next LUB meeting would be a Completeness Hearing for the application many are interested in. Councilmember Ryan explained the process of the LUB to the public, so they would better understand how an application is handled.

Police Chief Report

Chief Burton explained that there had been some recent vandalism and that the juvenile responsible had been apprehended. He announced that people should call the Police not post on Facebook if there is a police matter. Additionally, Chief Burton noted that there would be an officer directing traffic at the Seastreak at their expense.

Councilmember Broullon provided an update to the residents on various issues including but not limited to sprinklers, the tax abatement ordinance, Highlands Elementary drainage, mowing, and paving.

Public Comment

Councilmember Broullon opened the meeting to the public.

Scott Breslow, Paradise Lane, inquired if the ordinance changing the name of Lighthouse Point Road to Paradise Lane could be appealed. Councilmember Broullon explained why it was changed originally. Mr. Breslow commented that changing the name was very disruptive to the residents, the communication with Pulte was lacking, and the residents were not informed of the change. Council agreed to discuss it.

Greg Wells, Bayside Drive, stated that the group opposed to the detox center on Bay Avenue had obtained legal counsel, will have expert testimony, and have an established a non-profit. He noted that they would be holding meetings and requesting donations.

Kim Skorka, Shore Drive, asked that yellow curbs are painted, and Ms. Gonzales ensured they would be.

Carol Bucco, Shore Drive, inquired what a 'Public Officer' was. Councilmember Broullon explained that it was an annual requirement to appoint this position. Ms. Bucco asked if the Borough was being charged a 'fuel charge' by the trash hauler. Mr. DeBlasio stated that it would be investigated. Ms. Bucco stated that she objected to the name Paradise Lane.

Ms. Bucco informed the Council that she had sent correspondence to Ms. Gonzales concerning the use of the Community Center by various groups and the noted the response received. She followed up with various questions concerning the usage. Councilmember Broullon explained the process to approving the usage for these groups. Councilmember Braswell pointed out that there had been no issues and that the Borough has a one strike policy. Ms. Bucco continued to express her concerns.

Andy Danio, Miller Street, responded to some of Ms. Bucco's concerns.

Chris Francy, Fifth Street, questioned if the Borough already had one of the bond ordinances that had been introduced tonight. Mr. Chabarek explained the need for the ordinance. Mr. Francy also expressed concern over Seastreak's new larger boat and the safety of smaller boats in their immediate area.

Trisha Rivera, Waterwitch Avenue, said that the Council cannot stop or limit the public when they are speaking. Ms. Rivera noted her concern over the height and size of the homes being built and asked that this bee looked at and addressed. Councilmember Braswell provided a history of the height requirements in the Borough. Ms. Rivera explained why she believed they were too high.

Ms. Rivera questioned what was being done concerning the flooding. Councilmember Broullon reviewed what the Borough was currently doing to address the issue. Ms. Rivera suggested an additional pump station was needed. Ms. Gonzales reviewed all the Borough was doing to fight flooding in the Borough and Council discussed the issue with Ms. Rivera.

Tom Reed, Snug Harbor Avenue, expressed his concern over the use of the Community Center by certain groups due to liability. He pointed out that he supports these groups' missions but thought the location was a poor choice and affects the quality of life of the Borough's residents.

Steve Solop, Bay Avenue, inquired on the status of officers on bikes and Chief Burton said he would speak to him after the meeting. Mr. Solop inquired if there was any progress on the recommendations from Councilmember D'Arrigo and himself concerning the Highlands Business Partnership (HBP). Some of the Council stated that they had not been provided the list which Councilmember D'Arrigo noted she had distributed it. Mr. Solop pointed out that the HBP doesn't follow the Borough's ordinance and are the only ones benefiting from their events. He noted that the businesses in the middle of the Borough are being ignored by the HBP.

Linda Mazzola, Marina Drive, inquired who pays for the operation of the Community Center. Council explained that it is funded by taxes, but groups pay a fee for usage. Ms. Mazzola said that in her field any group is a liability and requires insurance. Ms. Gonzales noted that all groups provide liability insurance and sign a hold harmless. Ms. Mazzola announced that insurance will not cover a fight or harm to a child. She stated that the Community has the right to know who is using the Community Center and when.

Ms. Mazzola inquired the role of the HBP in the Borough's events. Councilmember Broullon listed the things HBP does not including the events which included providing grants, advertising, and hosting meetings. Ms. Mazzola noted that she sees the HBP as a positive thing. She questioned what the HBP s thought on the detox center and said that she was told they would have to poll the businesses to provide a response. Council explained that the HBP was a separate entity. Ms. Mazzola quested Councilmember Broullon if all the businesses were aware of the application for the detox center.

Mike Cannon, Central Avenue, noted his concern over the 'sunny day' flooding on Snug Harbor area. He noted that there are puddles and water bubbling out of the drains. He also added that the flood valve is not working at Jones Creek.

Steve Solop, Bay Avenue, provided a copy of the HBP ordinance to the Council.

Councilmember Broullon closed the meeting to the public.
