### **Public Portion:**

Barbara Ianucci of 28 Shrewsbury Avenue questioned the fiducial due diligence for the Community Center repairs. She spoke of using local contractors would be less costly. She questioned the flood insurance premiums for this building.

Mr. Padula stated that we can't just pick a local contractor. We still have to bid, no matter what. The pay rate the contractor pays is set by statute. They have to pay prevailing wage. They have to pay union labor.

Barbara Ianucci spoke about volunteers doing the work instead of involving FEMA and T&M doing the process for us.

Mr. Hill added that any local contractor could have submitted a bid.

Barbara Ianucci questioned flood insurance rates.

Mr. Hill explained stated that we continually look at the flood insurance programs. He further explained.

Barbara Ianucci continued to question lifting the building in the future and to reduce the flood insurance.

Barbara Ianucci continued to discuss various ways to lessen the cost of insurance in the long term with the council regarding the Community Center and other projects in town.

Mayor Nolan added that he is glad that we have professionals for the project.

Mayor Nolan offered a motion to adjourn, seconded by Mrs. Kane- Wells and all were in favor.
