Disposal of Bridge Pylons

Mr. Geoghegan stated that the Borough needs to decide on a line of action for the pylons which was discussed. It was determined to incorporate them into a sign at Veterans' Park and how to move them would be investigated. Carla Cefalo Braswell of the Highlands Business Partnership was asked to bring drawings to the Borough and Mr. Leubner was asked to explore footings.

Administrator's Report

Mr. Geoghegan updated the Council on paving, improvements to basketball courts at Veterans' Park, the summer recreation program, Monmouth Hills, and the Highland's Elementary School drainage issue. He also provided the Council a timeline for moving Borough operations to the new trailer.

Rock Incident

Councilmember Card denounced the recent incident where a rock was found near the Community Center with offensive symbols language painted on it. Acting Chief Burton announced the case was closed earlier in the day.

Road Improvements

Councilmember Broullon recommended adding Hillside Road into the Portland Road project as the street is in poor shape.

Deaths

Mayor O'Neil shared the sad news of the Garden Club's President Dodie Bower's passing and noted all the wonderful things she did for Highlands.

Land Use Board

Mayor O'Neil noted that Jimmy Fox resigned from the Board and will be missed.

Public Comments:

Mayor O'Neil opened the meeting to the public for comment.

Steve Solop, Bay Ave, expressed that the Highlands Business Partnership (HBP) is a wonderful organization and was impressed by their dedication. He commented, as a business owner he is concerned that he doesn't get a return on his investment into the HBP. He suggested a task force be created to look for ways to improve the HBP and be more inclusive. Council discussed ways to assist the HBP and how an outside evaluation can be useful.

Chris Francy, Fifth Street, expressed his frustration at that Council has not committed to the improvements on Valley Street. Mr. Leubner explained the delay in the project. Mr. Francy and the Council debated the advantages and disadvantages of completing the project as a whole compared to splitting it into smaller projects.

Carol Bucco, Shore Drive, questioned if the rumor she heard concerning Seastreak building a large parking garage was valid and she was informed that the Borough knew of no such plans. She suggested various methods to control and correct the parking situation caused by Seastreak patrons.

Carola Cefalo Braswell, Gravely Point Road, stated she spoke to Seastreak directly on the rumor and it was false. She inquired if the JCP&L lights could be dimmed for the decorative lights and was advised legally that was not an option. Ms. Cefalo Braswell questioned the status of installing electricity to Veterans' Park. Mr. Leubner advised her of the status and issues the Borough is facing with that project. Council discussed how to proceed.

Authorization to move forward with bringing electricity to Veterans' Park if the funds were available. Councilmember Broullon motioned to have the Chief Financial Officer look for \$15,000.00 in the budget to cover the additional line items needed to bring electricity into Veterans' Park, notify the Governing Body if located, and have Mr. Leubner immediately contact JCP&L to move forward, which was seconded by Councilmember Wells.
