The code enforcement officer shall be appointed by the mayor, with the advice and consent of the council for the term of one year, and until his successor shall have been appointed and qualified.

The code enforcement officer shall-may be a part-time <u>or full-time</u> position.

The hours constituting such part time services shall be as hereinafter fixed by resolution of the governing bodymayor and eouncil of the borough.

The annual salary for a part-time the code enforcement officer shall be established by resolution of the governing body, consistent with the Borough's salary ordinance.not exceed the sum of six thousand (\$6,000.00) dollars per annum.

SECTION TWO. The Borough's current salary ordinance, O-13-24, shall be amended to provide a maximum annual salary of \$70,000.00 for the position of Code Enforcement Officer.

Report to Council December 2015

On November 15, 2015, the Highlands Police Department executed a search warrant at 100 Navesink Avenue arresting two suspects, seizing two vehicles, and confiscating approximately eight (8) pounds of marijuana, cocaine, crack cocaine, liquid THC, methamphetamine, xanex, oxymorphone, oxycotin, suboxone, phychedelic mushrooms and psilocybin, as well as, recovering brass knuckles, a stun gun, machete, and a long rifle BB gun.

During the early morning hours, Sgt. Roxby, while on routine patrol, observed a suspicious vehicle in the parking lot of the complex at 100 Navesink Avenue and when he approached the vehicle found the occupant to be using narcotics. Sean W. Laone, 25 years old, 100 Navesink Avenue, Highlands, was subsequently arrested and charged with three (3) counts of possession of a controlled dangerous substance; specifically

oxycodone, cocaine and marijuana candy, possession of drug paraphernalia and possession of a controlled dangerous substance in a motor vehicle.

Riker were also conducting an investigation after developing information regarding the sale and distribution of narcotics from the residence which led to the execution of the search warrant and Sean Laone's additional charges which included being a leader of a drug trafficking network, possession of a controlled dangerous substance with the intent to distribute, possession of a controlled dangerous substance within 500 feet of a park, eight (8) counts of possession of a controlled dangerous Substance; specifically marijuana, cocaine, xanax, oxymorphone, oxycodone, suboxone, dextroamphatamine, and crystal methamphetamine, unlawful possession of a weapon; specifically for a stun gun, rifle and brass knuckles. Mr. Laone was subsequently transported to the Monmouth County Correctional Institution, Freehold, in lieu of \$590,000.00 without a 10% option.

Ashleigh P. Fields, 24 years old, 100 Navesink Avenue, Highlands, was charged with conspiracy as a leader of a drug trafficking network and arrested on November 18, 2015. Ms. Fields was also transported to the Monmouth County Correctional Institution, Freehold, in lieu of \$250,000.00 without a 10% option.

As always, the Highlands Police Department encourages anyone with information regarding narcotic sales, distribution or any suspicious activity to report it to the police. All information will be kept confidential and everyone has the right to remain anonymous.
