Councilmember Ryan stated that Mr. Rosiak is hurting the clammers, not the Council, and noted that the Council must also think about the residents. Mayor O'Neil stated that he needs to complete the work. The Council continued to discuss this with Mr. Eisemann

Name: Willie Rossetti Address: Sea Drift

Explained the flood waters come up from the sewer because outfall pipes were removed from the bulk head, in addition to, the storm and sanitary sewers being connected. He suggested hiring an engineer that has experience with water. Mayor O'Neil noted that the Council is doing the nest they can.

Name: Raymond Philips Address: Forth Street

Acknowledged that the Council had been very patient with Mr. Rosiak. He stated that Mr. Rosiak was receiving treatment in the morning and working on the marina in the afternoons. Mr. Philips pointed out that all the materials were at the property. Council again confirmed that Mr., Rosiak can have his mercantile back when the repairs have been completed.

Ms. Gonzales noted that there were other issues with the property including backfilling with clay. Councilmember Ryan further explained that there were other things then the thirty (30) feet of wall that needed to be repaired. Mayor O'Neil stated that this does not stop him from completing the work and when he does he can have his mercantile license returned.

Mr. Philips stated that the clammers have no money to go to another marina and pleaded to extend the deadline. He stated that him and others would be willing to help with the repairs.

Ms. Kaemmerer noted that building at the Shadowlawn property could really impact other parts of the Borough due to the slope. She added that she just would like to see this done right. She also expressed her concern over the traffic on Linden Avenue and was concerned over safety. Ms. Gonzales stated that she met with the County today on that topic and asked them to conduct a traffic study on Linden
