ORDINANCE O-21-18

AN ORDINANCE AMENDING CHAPTER 2-5.8 OF BOROUGH CODE WITH REGARD TO ISSUANCE OF BINGO AND RAFFLE LICENSES

WHEREAS, in accordance with <u>N.J.S.A.</u> 5:8-31, no games of chance shall be conducted under any license issued under this act on the first day of the week, commonly known and designated as Sunday, unless it shall be otherwise provided in the license issued for the holding, operating and conducting thereof, pursuant to the provisions of an ordinance duly adopted by the governing body of the municipality issuing the license, authorizing the conduct of such games of chance under this act on said day.

WHEREAS, the governing body of the Borough of Highlands wishes to allow for such games of chance to be conducted on Sundays

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Highlands, County of Monmouth, State of New Jersey, as follows:

SECTION 1. Games of chance, including Bingo and raffles conducted pursuant to a valid license, may be conducted on Sundays subject to such approvals of the Borough governing body and/or Borough Clerk.

SECTION 2. Chapter 2-5.8 of the Borough Code of the Borough of Highlands, entitled "Issuance of Bingo and Raffle Licenses, shall be amended to read as follows (additions are shown in *bold italics with underlines*):

2-5.8 Issuance of Bingo and Raffle Licenses.

The governing body hereby delegates to, authorizes, and provides authority to the borough clerk to issue bingo licenses and raffle licenses to appropriate organizations as specified in the Bingo Licensing Law and the Raffle Licensing Law, in appropriate applications in the determination of the borough clerk. Such License issuance will thereafter be reported to the Borough governing body. <u>A bingo license or raffle license may be issued for such events to be conducted on Sundays.</u>

SECTION 3. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance, which shall otherwise remain in full force and effect.

SECTION 5. This Ordinance shall take effect immediately upon its passage and publication in accordance with law.
