BOROUGH OF HIGHLANDS COUNTY OF MONMOUTH

AN ORDINANCE AMENDING CHAPTER VII, SCHEDULE 1 "NO PARKING" OF THE CODE OF THE BOROUGH OF HIGHLANDS RELATED TO AREAS OF NO PARKING IN VARIOUS LOCATIONS THROUGHOUT THE BOROUGH

WHEREAS, Chapter 7, Section 3.4 of the Borough Code establishes the streets or parts of streets where there shall be no parking; and

WHEREAS, the Chief of Police has analyzed and evaluated the Borough Code and has recommended certain changes; and

WHEREAS, the governing body finds that these recommendations should be adopted for the general safety, health and welfare of the Borough.

NOW, THEREFORE, BE IT ORDAINED by the governing body of the Borough of Highlands as follows:

SECTION I.

Borough Code Section 7-3.4 entitled "Parking Prohibited at All Times on Certain Streets", Schedule I, Section 7A-1 entitled "No Parking", shall be amended as follows: (All additions are shown in *bold italics with underlines*. The deletions are shown as *strikeovers in bold italics*.)

Prospect Street	South	From the eastern side of the concrete steps at #9 Prospect Street (Block 28, Lot 9.01) to the intersection with Woodland Street.
South Peak Street	<u>West</u>	Thirty (30) feet south of the stairs at #7 South Peak St (Block 26, Lot 4.01).
South Peak Street	East	Highland Avenue to Grand Tour.
Willow Street	<u>Both</u>	Entire length.

SECTION II. SEVERABILITY. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance, which shall otherwise remain in full force and effect.

SECTION III. <u>REPEALER</u>. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV. EFFECTIVE DATE. This Ordinance shall take effect after final passage as provided by law.
