Monmouth County Dispatch

Ms. Gonzales stated that the County offered this shared service and noted that the Council had toured the facility. Undersheriff Robert Dawson reviewed the visits the Council had and noted that Highlands would be one of twenty-four (24) municipalities using their dispatch services. He noted that this had been discussed with Chief Burton and an equipment assessment had already begun, explaining how outdated the Borough's equipment was.

Pat Mason, Highlands OEM Coordinator, stated that OEM is already on the County dispatch, but the fire department had concerns over their frequency. Undersheriff Dawson stated that they tested the fire department's frequency last night and were satisfied with the results. Mr. Mason confirmed it worked, noting some areas are still spotty. He inquired if the fire department would be able to continue to use their own channel and Undersheriff Dawson stated that it is encouraged.

Council asked if the public had any questions.

Name: Chris Francy Address: Fifth Street

Asked why this system was better then the status quo and how much will it cost the Borough.

Undersheriff Dawson explained that the County already handles the Borough's 911 service, so this will increase information sharing and mapping for an OEM standpoint. He also added that it will rid the

Borough of personnel needs. Mayor O'Neil stated that the County has state of the art technology which Councilmember Ryan explained in more detail.

Councilmember Broullon inquired if the Borough's personnel could apply to work for the County and Undersheriff Dawson explained that they encourage it.

Name: Kim Skorka Address: Shore Drive

Explained that there is constant confusion between Atlantic Highlands and the Highlands, in addition to, similar street names such as Bay Street and Bay Avenue and asked if this would cause delays in emergency services arriving.

Undersheriff Dawson explained that the system is not perfect, but they use GIS which helps them to pinpoint where a cell phone is calling from and maps the location. He did acknowledge that the landline State system, which only make up 10% of their calls, is antiquated.

Ms. Skorka inquired if Atlantic Highlands used their service. Undersheriff Dawson confirmed that they don't currently, but it is only a matter of time before they use the County as well.

Undersheriff Dawson informed the public that their dispatchers are all trained in emergency medicine along with being required to go through rigorous training prior to answering calls.

New Municipal Building

Architect Kevin Settembrino presented the current plans for the new municipal building to the Council and public. He noted some of the changes that have occurred since the initial set of plans and reviewed the floor plans. Mayor O'Neil explained why the building was positioned in the matter it was to provided police direct access to Route 36 and minimize the impact to the neighborhood. Mr. Settembrino continued to review the exterior plans, elevations, and building materials.

Mayor O'Neil stated that the second floor which would be administration and secured at night.

Ms. Gonzales reported that she had met with several residents and the State, in addition to, having some meetings on potential shared services. She updated the Council and public on the status of the Valley Street Project, Waterwitch Avenue stormwater and sanitary sewer improvement project, and Veteran's Park electric. Stated that he kept seeing "Highlands Business Partnership" on the Executive Agenda and as a member of the Business Improvement District he has the right to know what they are discussing. Mr. Chabarek explained the process to amend the redevelopment plan, listing all the opportunities the neighbors would have to comment on the plan prior to adoption. Councilmember Ryan explained that this would just be a change not a full study. Mayor O'Neil stated that the Borough is in receipt of plans from a potential redeveloper to fill in the marina and place fourteen (14) homes there with 16-20 boat slips. Mr. Chabarek again noted when the public would have the opportunity to weigh in on these plans and noted the point of redevelopment.

Ms. Clitheroe stated that she felt there was nothing the neighbors could do to stop this from happening. Mayor O'Neil explained why a two hundred (200) foot list would not be required. Councilmember Ryan explained that this is a private business transaction. Councilmember Braswell explained why the marina, the way it is, is a liability to the Borough and the neighbors. Ms. Groves asked the Council to work with and listen to the neighbors.

She said that the Borough's biggest assets is the waterfront which this plan would destroy. She announced that this would negatively affect the neighbors and clammers, noting this is not in the best interest of the residents.
